### **Rental Size and Description:**

Each space is 20'x10' You must provide your own equipment, (i.e. tables, chairs, & display stands). This is an OUTDOOR Event. Please bring a canopy shelter. No Norfolk County Vendor permit required.

### **Space Rental Costs:**

\$135.00 for three days or \$65.00 per day - Each 20 x 10 ft space - Non Food Vendor

\$200.00 for three days or \$100.00 per day - Food Vendor - No Power Supplied - Noise Reduced Generator required.

### **Set-Up, Take-Down:**

Friday set - up by 3pm till 9pm - Saturday is from 10am till 9pm - Sunday is from 10am to 5pm

Take-Down can start after 4:30pm on Sunday

### **Space Rental Agreement:**

1. Vendors must be ready and open for business at the times specified.
2. Vendors are not guaranteed exclusive rights to any product.
3. No Refunds will be given.
4. Delhi Fall Fest is not responsible for any losses due to fire, smoke, water, or any other causes to his/her goods.
5. Vendors agree to participate for all 3 days unless application submitted is for specific days.
6. Vendors shall not tear down, pack away, or remove any items prior to 4:30pm Sunday.

Norfolk County requires that all vendors are in compliance with the following requirements: Note: Vendors conducting any cooking activities must also complete the Vendor Fire Safety Requirements for Cooking Conditions Form.

**Portable Fire Extinguisher Protection:**

- Vendors must have a portable fire extinguisher with a minimum 2A10BC rating. The extinguisher must have a technicians tag certifying maintenance within the last 12 months.

**Tents:**

Any Tent, tarp, canopy or similar shelter being used at the event must:

- Have an aggregate area of less than 60sq. M (645 sq. Ft). Larger tents require approval through building permit application and inspection.

- Must be labelled or have documentation confirming the tent material has a high degree of flame resistance in accordance with standards set by one of: NFPA 701, or CAN/ULC S-109.

Multiple tents in a grouping shall not exceed an area of 60 sq. m. (645 sq. ft) without a minimum 3m fire break separating the grouping from other tents or structures.

**Electrical Service:**

- Any electrical work will be undertaken by a qualified, licensed electrician, and will be subject to inspection by the Electrical Safety Authority.

- All electrical equipment used shall be listed and approved for use in Canada.
